**ANY RESIDENTIAL PERMIT** .....\$4.75 per thousand\*<sup>1</sup>

**NON-RESIDENTIAL BUILDING PERMIT**

\$1.00 - \$1,000.99 ..... \$53.00\*<sup>1</sup>

\$1,001 & up .....\$53.00 plus\*<sup>1</sup>  
 \$3.00 per thousand

**Plan Review Fee**.....½ Permit Fee\*<sup>2</sup>

**MECHANICAL, ELECTRICAL, PLUMBING, GAS, SIGNS, SWIMMING POOL & FIRE PROTECTION PERMITS**

Construction Cost

\$1.00 - \$2,000.99 ..... \$53.00

\$2,001 - \$50,000.99.....\$53.00 plus  
 \$5.25 per thousand over \$2,000

\$50,001 - \$100,000.99.....\$305.00 plus  
 \$4.25 per thousand over \$50,000

\$100,001 - \$150,000.99.....\$517.50 plus  
 \$3.25 per thousand over \$100,000

\$150,001 - \$200,000.99.....\$680.00 plus  
 \$2.50 per thousand over \$150,000

\$200,001 and Up.....\$805.00 plus  
 \$2.00 per thousand over \$200,000

**Plan Review Fee** ..... ½ Permit Fee\*<sup>2</sup>

**RE-INSPECTION FEE** .....\$75.00

For 2nd and subsequent inspections per permit

**PERMIT RENEWAL &/or UPDATE FEE**

\$53.00 per each renewal. All permits expire 180 Days after issuance or last inspection.

**DEMOLITION PERMIT**.....\$105.00

**MOVING PERMIT** ..... \$105.00

**MOBILE HOME/CONSTRUCTIONTRAILER**

Setup/Electrical.....\$75.00

**OTHER COMMERCIAL PERMITS**

Change of Occupant Fee..... \$53.00

Code Analysis/Life Safety review fee for Change of Occupancy..... \$105.00

*\*When a change of occupancy type is made of a facility it may require a code analysis to be completed by a registered architect.*

**SHEDS/UTILITYSTRUCTURES/OTHER**

Construction Cost

\$1.00 - \$2,000.99 ..... \$32.00

\$2,001.00 and Up.....\$32.00 plus  
 \$4.75 per thousand over \$2,000

**Penalties:** Where work has begun prior to obtaining permits required by State Law, the fees herein shall be doubled. Payment of this fee does not relinquish any duties or responsibilities set forth by State Law.

\*<sup>1</sup>Valuation for New Construction is based on the current ICC Building Valuation Data (BVD).

\*<sup>2</sup>Plan review fees must be paid at time of plan submittal (office will contact you with payment instructions).

**In the event of a request for cancellation or refund of a permit, if granted, a \$32.00 administrative fee will be charged. Refunds and cancelations cannot be issued once reviews are completed, inspections conducted or if permit has expired.**
